MORTGAGE, RENT, AND UTILITY BILLS DURING THE COVID-19 PANDEMIC

Contact your mortgage servicer (the company where you send your monthly payments) as soon as possible to let them know about your current circumstances. The telephone number and mailing address of your mortgage servicer should be listed on your monthly mortgage statement. Mortgage Relief can include no late fees, no delinquencies reported to credit bureaus, foreclosures and legal proceedings suspended.
